

CHAPTER I

INTRODUCTION

1.1 Background of the Study

Language is very important in the world. Every nation has its own language. Language is a symbol of a country. As a symbol of a country, it should be kept and also developed time to time. According to Wardhough (1986:3), “Language is system of arbitrary vocal symbol use for human communication”. It is important because language plays an important role in terms of communication and interaction with another country in the world by mastering language. People could compete with another country. Language in this context does not means Indonesia language only, but for whole kinds of languages in the world, includes English an international language.

action itself, but instead caused someone or something else to do it. Causative verb are used to indicate that one person means another person to do something for them. The true causative verbs are: have, get, and make.

The researcher believes that often use causative verb in daily life. For example:

Let : Let her say what she wants.

Have (Had) : Ali had Farhan give him ten dollars.

Get : I got Farhan to give me ten dollars.

Make : He made a stranger on the street give him ten dollars.

The student often finds difficulties in using causative verb. The wrong use of this aspect may be caused error especially in two verbs in one sentence. As far as, researcher knows a research on the error in using causative verbs.

Based on this problem, the researcher would like to conduct a research which is entitled “Error Analysis of using Causative Verb at Class XI SMA Negeri 3 Langsa in Academic Year 2018/2019”.
